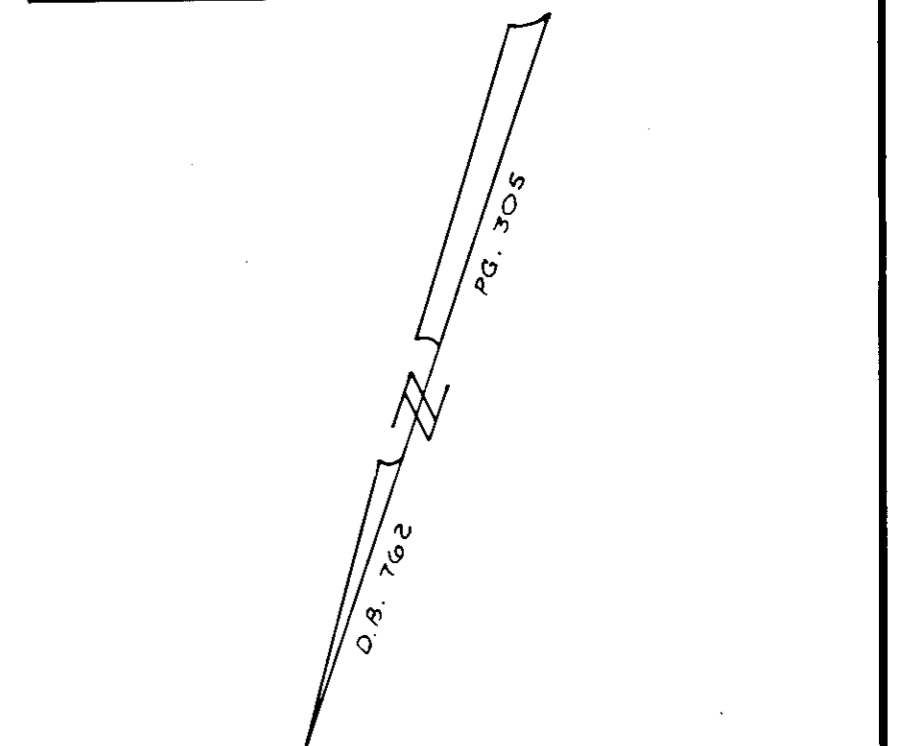
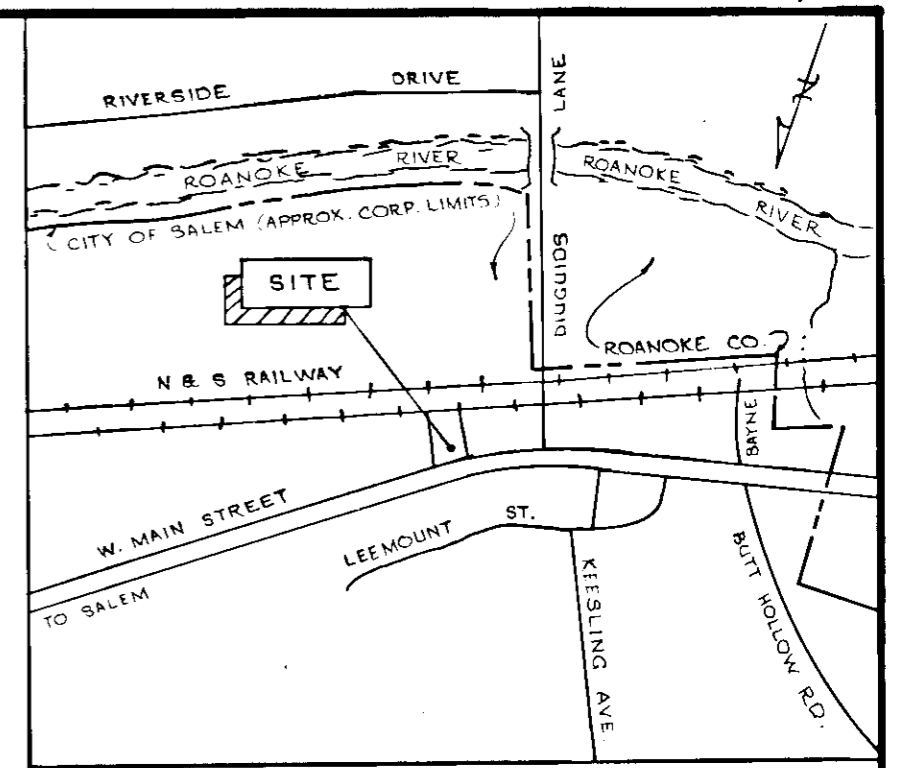
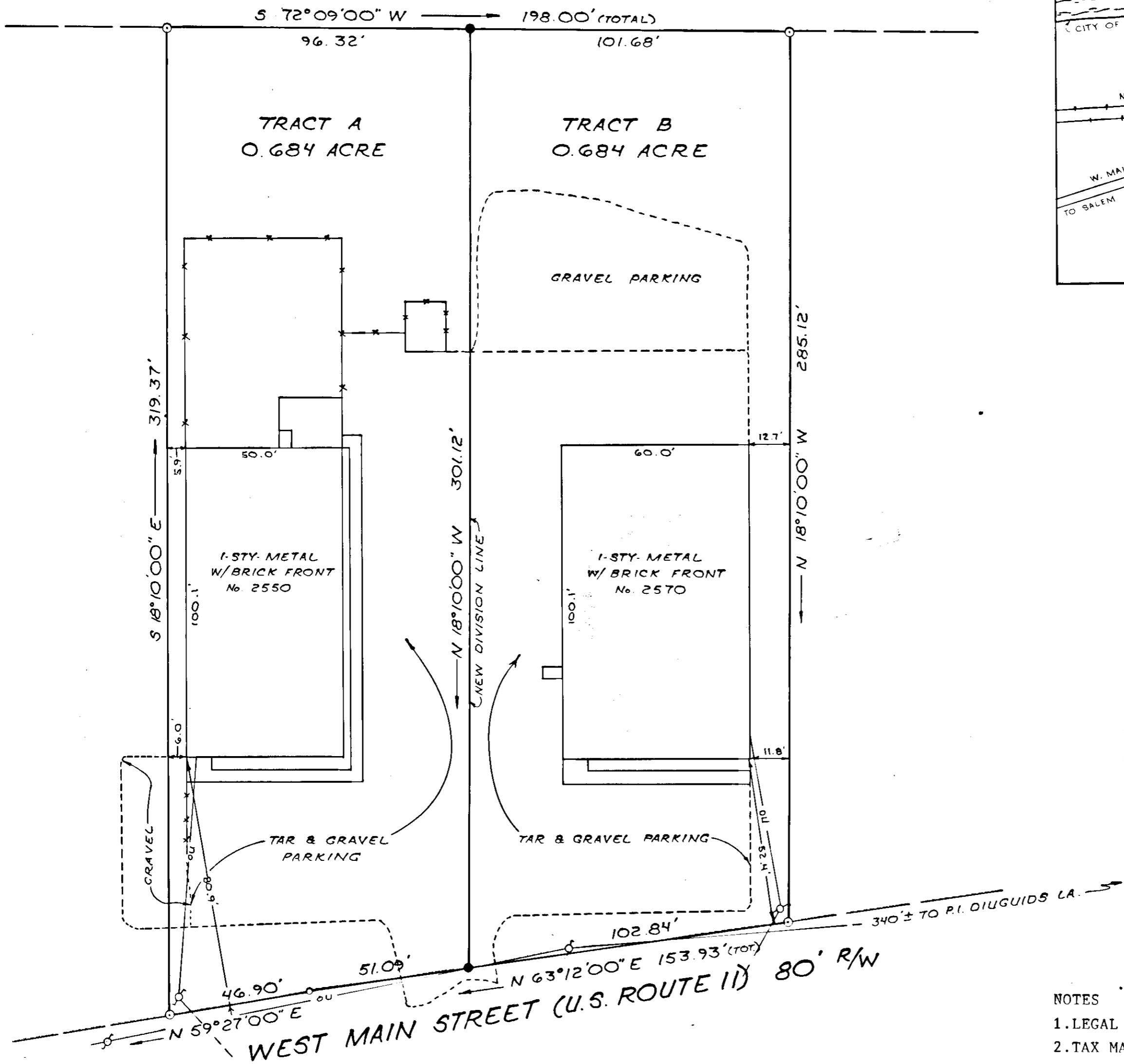


NORFOLK & SOUTHERN RAILWAY 80' R/W

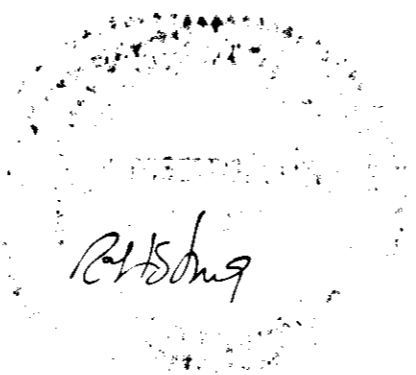
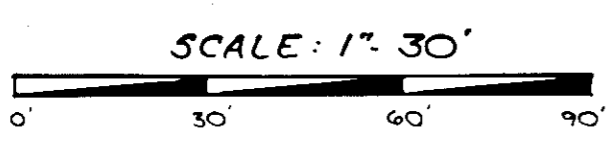
