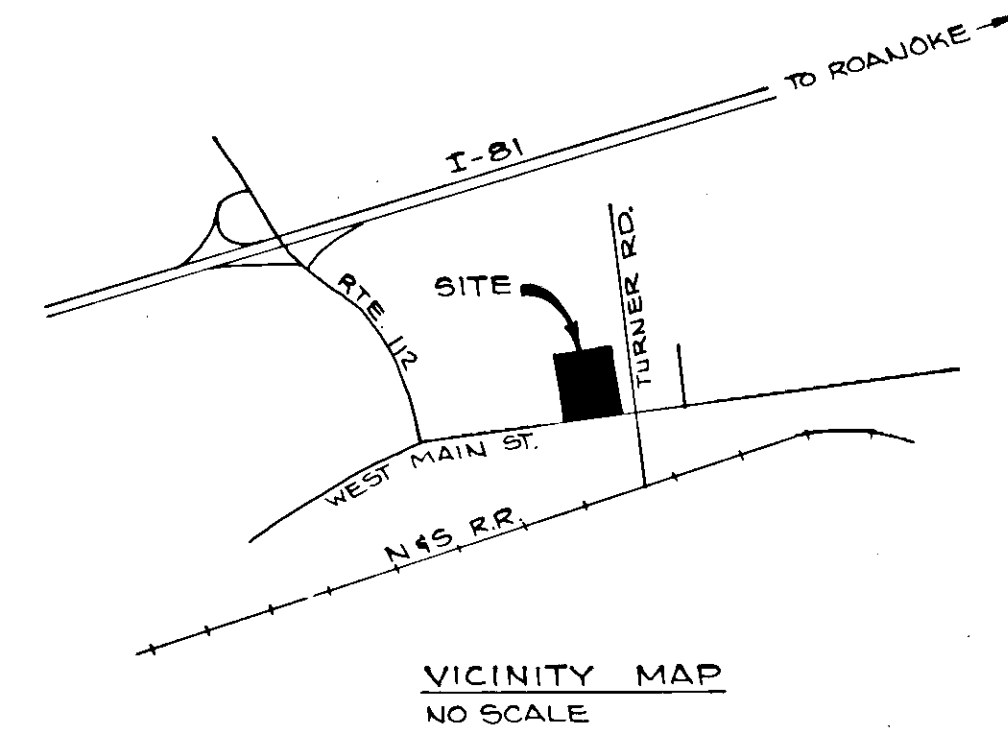


MERIDIAN OF D.B. 25, PG. 565



- NOTES:
1. AN EASEMENT FOR "AIR RIGHTS ONLY" IS GRANTED ACROSS THE WESTERLY PROPERTY LINE OF NEW TRACT "B" FOR PUBLIC UTILITIES. NO STRUCTURE, POLE, PEDESTAL, OR UNDERGROUND SERVICE WILL BE PERMITTED. IN THE EVENT THE CITY OF SALEM ABANDONS OR RE-ROUTES THE EXISTING OVERHEAD ELECTRIC LINES, THE EASEMENT OF OVERHEAD "AIR RIGHTS" SHALL TERMINATE. THE EXISTING POLE ALTHOUGH NOT PERMITTED BY THE EASMENT HEREBY GRANTED, MAY REMAIN IN PLACE UNTIL THE EXISTING OVERHEAD ELECTRICAL LINE IS REPLACED WITH A NEW OVERHEAD ELECTRIC LINE TO SERVE IMPROVEMENTS TO BE CONSTRUCTED ON NEW TRACT "A".
 2. THE SUBJECT PROPERTY IS NOT WITHIN THE LIMITS OF THE 100 YEAR FLOOD BOUNDARY AS SHOWN ON THE FEMA FLOOD BOUNDARY MAP.
 3. THIS PLAT OF SUBDIVISION IS SUBJECT TO INFORMATION WHICH MAY BE DISCLOSED BY A TITLE REPORT BY A LICENSED ATTORNEY.

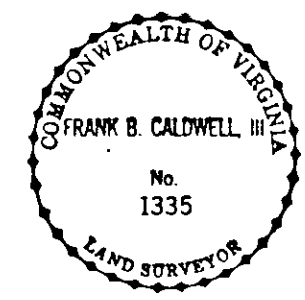
