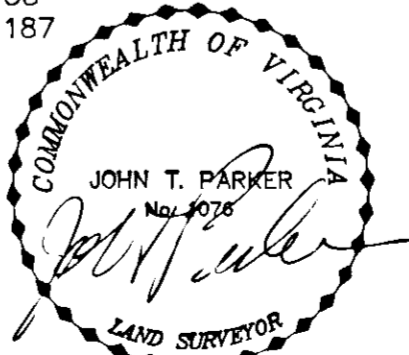

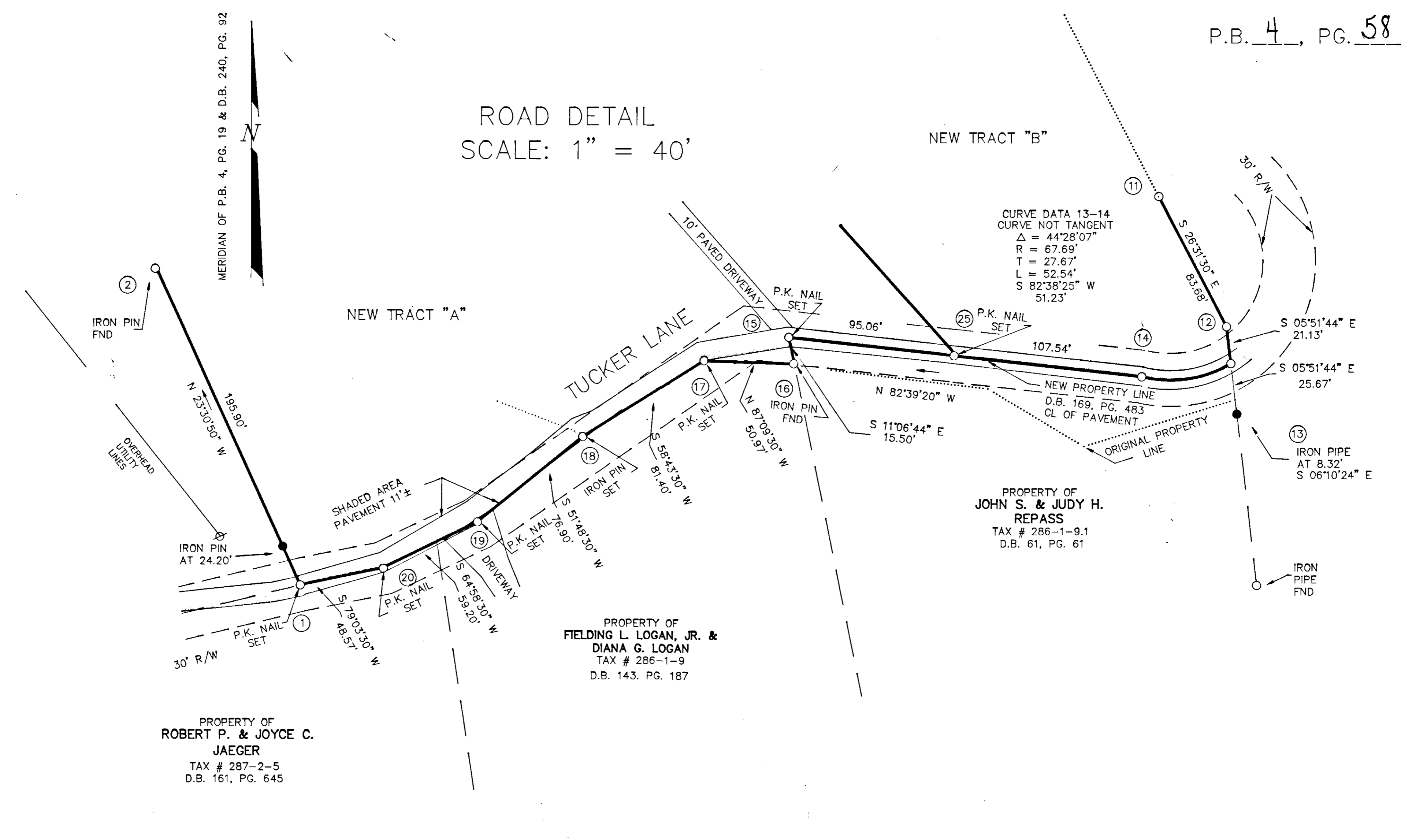


NEW TRACT "A" IS BASED ON A CURRENT FIELD SURVEY.

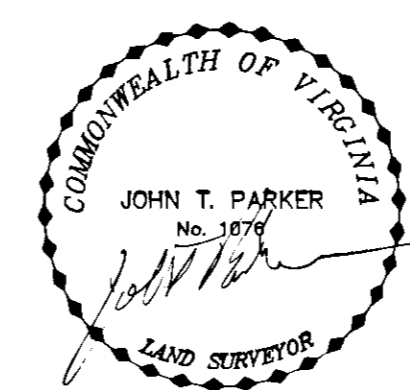
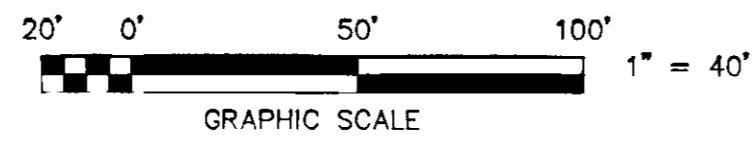
ROAD DETAIL
