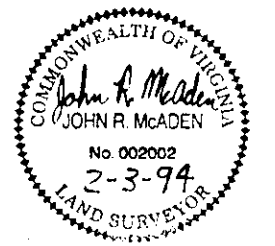

 ● IRON PIN FOUND

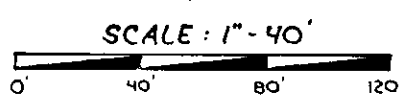
