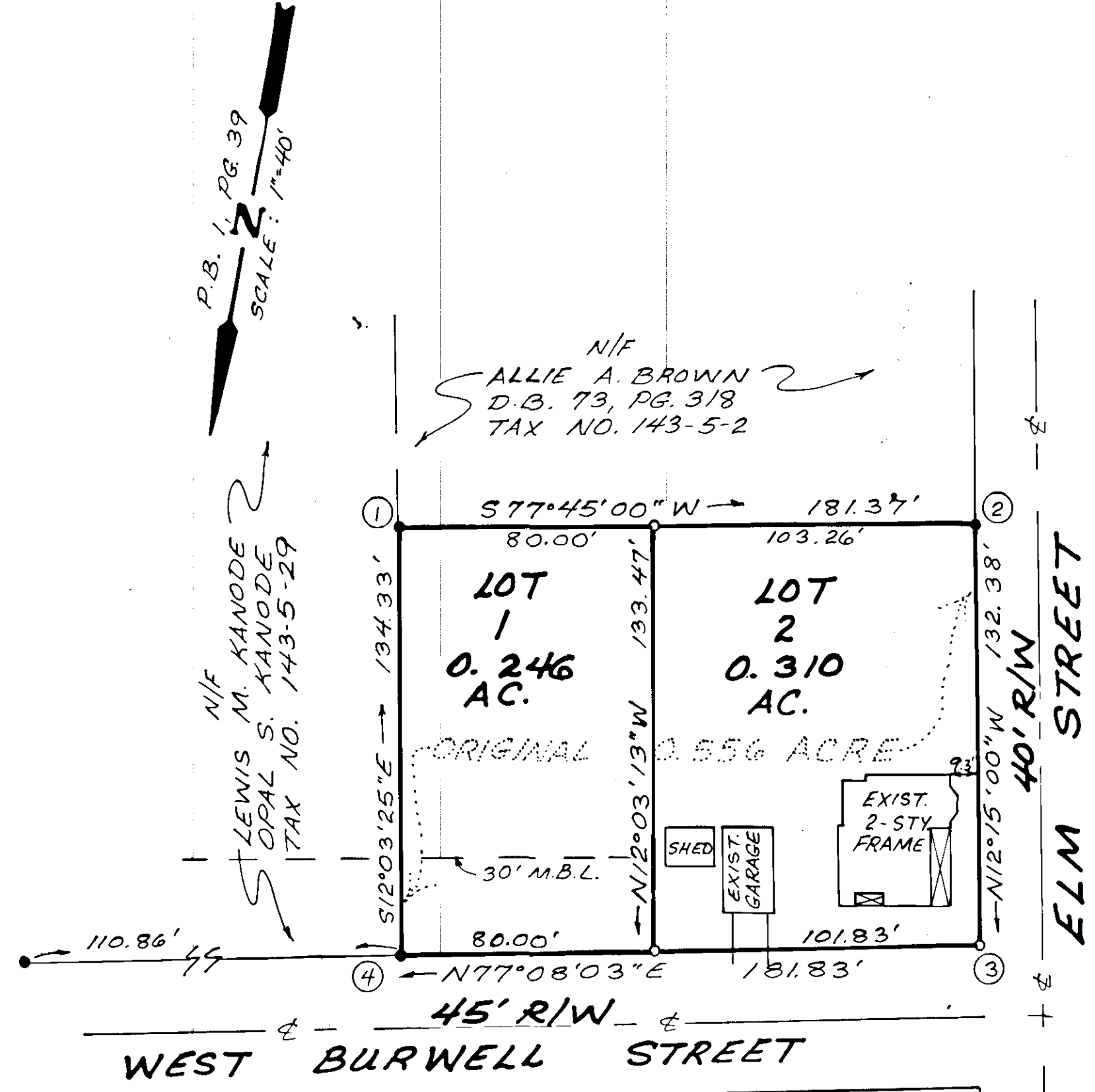

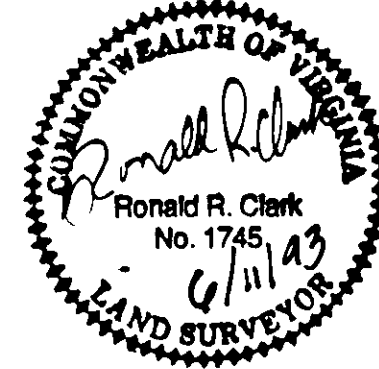


VICINITY MAP
