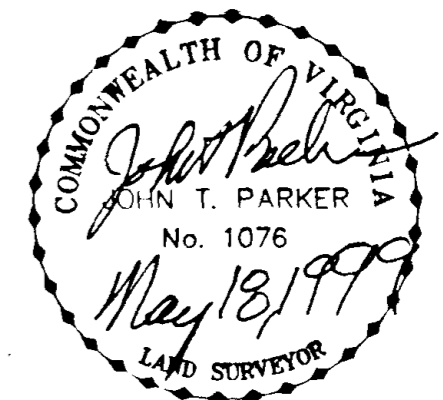

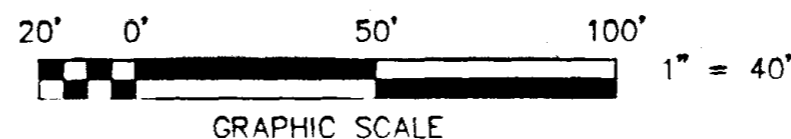
SHOWING A 0.57 ACRE TRACT AND A

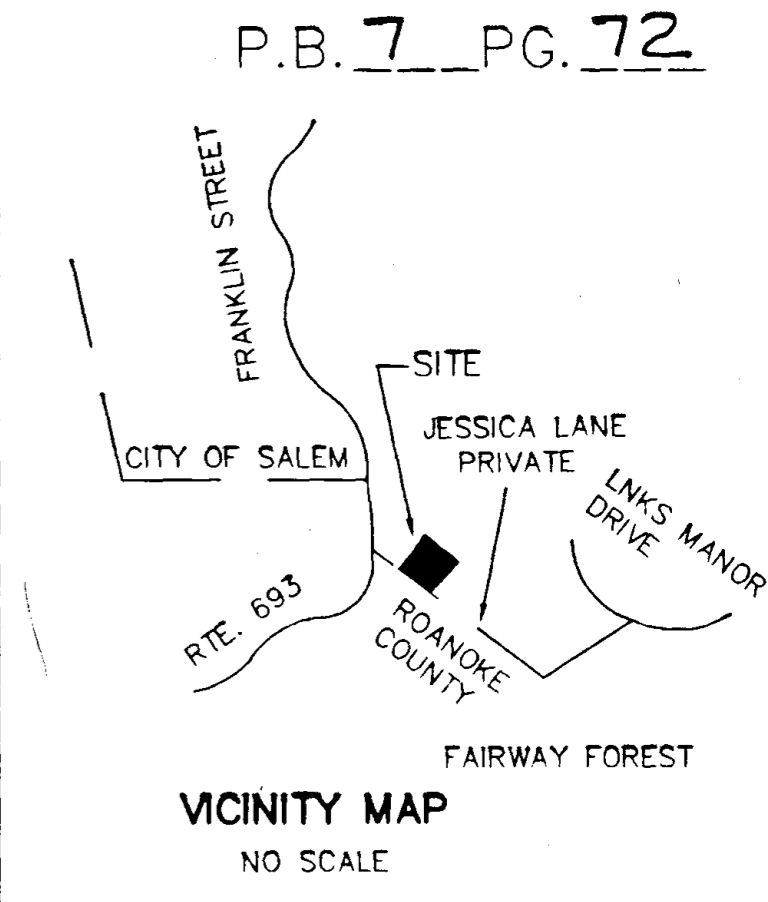
