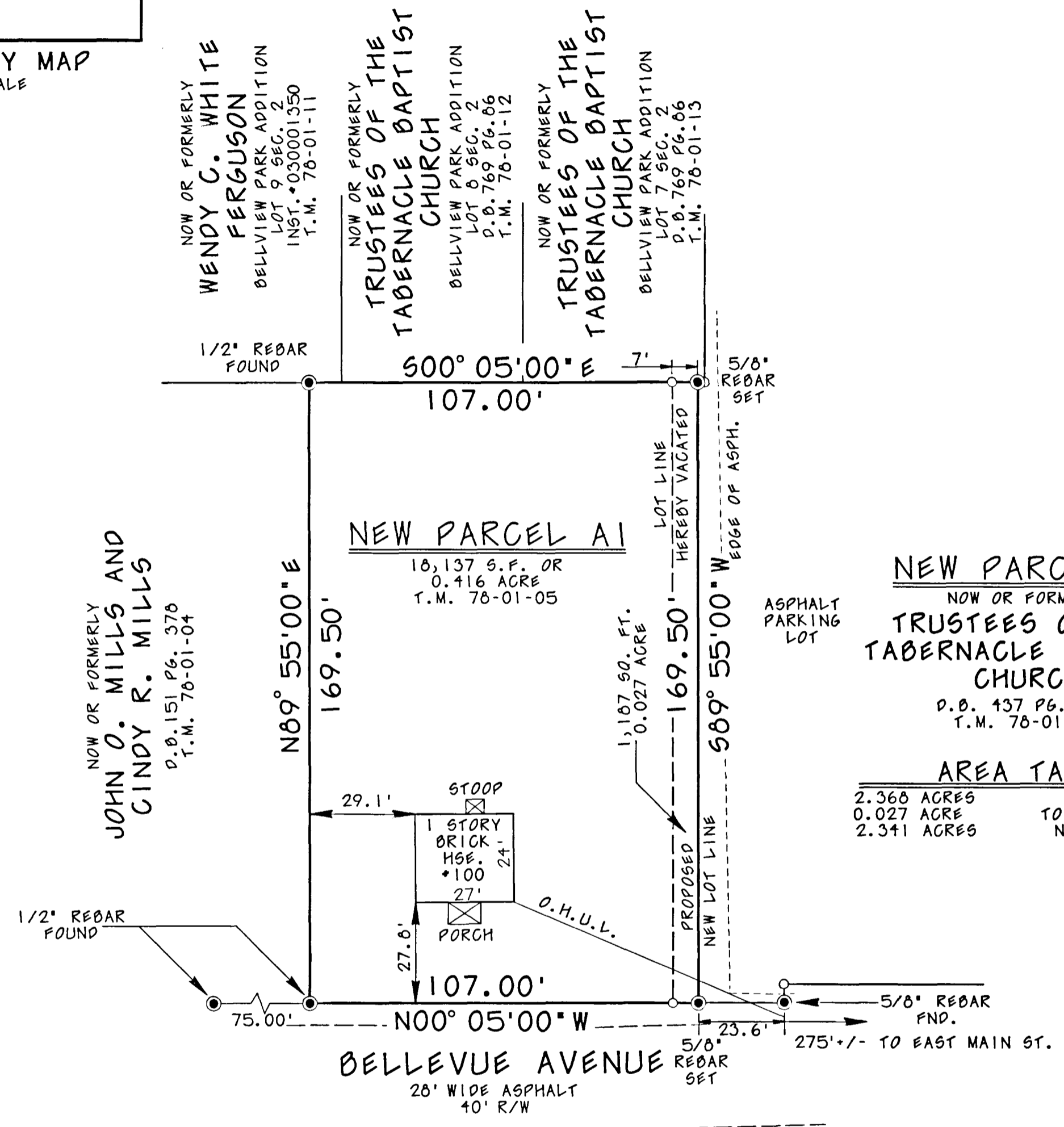
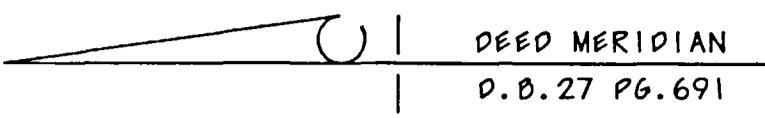


VICINITY MAP

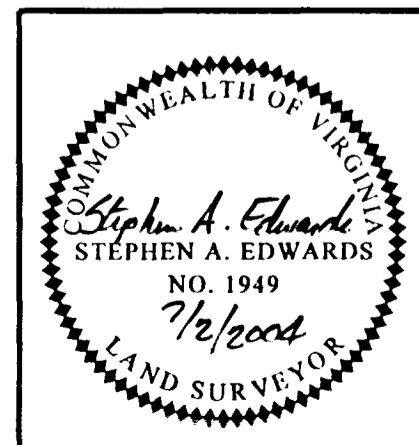
