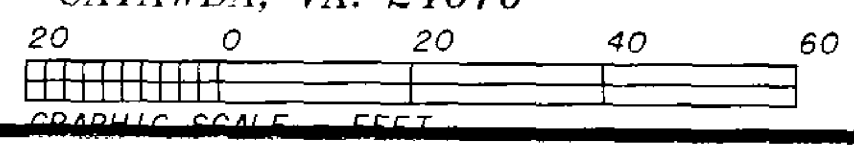
COMBINATION AND SUBDIVISION PLAT MADE FOR
