De Anthony Pierce: 32


Total votes: 598

The closed meeting of the City of Salem Electoral Board was held Wednesday June 21, 2023, beginning at 1 pm. Notice of the meeting was posted in accordance with Section 2.2-3707 of the Code of Virginia, 1950, as amended.

All of the members of the Board were present in person. Mr. Zachary Agee (Chair), Ms. Elizabeth Bowles (Vice Chair), and Ms. Katherin Elam (Secretary).

The sole purpose of this meeting is to be in accordance with 24.2-109-.1 of the Code of Virginia provides "the electoral board shall conduct an annual performance review of the general registrar for years ending June 30, 2006 and for years thereafter." Including 24.2-110 Code of Virginia - Appointment, qualifications and term of general registrar, vacancies, certain prohibitions. "General registrars shall serve four-year terms beginning July 1, 2007 and each fourth year thereafter, and continue in office until a successor is appointed and qualifies.

The Salem Electoral board reviewed and completed the four-part Virginia Department of Elections performance review form and concluded the meeting with the re-appointment of our registrar Dana Oliver for the term of July 1, 2023 until June 30, 2027.

The meeting ended at 2:25pm.
